

President's Report July 2014

Construction

Del Rio – Contractor has begun the final parking lot improvements, scheduled to finish by Sept. 5. We are tentatively scheduling our Del Rio Open House for September 19, 2014.

Eagle Pass – Staff and architects continue working on the details for the Eagle Pass project.

Crystal City – Our architects, staff, and civil engineers have been working with City staff to finalize the surveys and documents needed for the conveyance to occur. We are moving forward with the design of the building.

Uvalde – We have taken offline one wing of Hubbard hall to begin the major remodel to the existing dorm rooms.



Partnerships

HB5 – Our faculty and staff along with our area high schools met to develop the mandated remediation courses for high school seniors. We are also working with various school districts to expand their dual credit technical course offerings. We have attached a separate report regarding HB5.

4H Leadership Conference – Conference was a huge success. See attached letter from District 12 4H.

Del Rio San Felipe – Met with Dr. Rios, Supt., and discussed current and future collaboration between the school district and the college.

Other

Summer II Enrollment - Our unofficial enrollment totals for Summer II indicate about a 10% increase in credit hours from last year. We expect these numbers to decrease slightly after nonpayment students are dropped from the official rolls.

Vacation – I took a week vacation from July 1 – 8.

Conference – I attended the annual presidents' conference on July 9-12. The association finalized the 5 Point Legislative Plan and the \$2 billion funding request for the next biennium. Our base year begins with these summer terms, including next fall and spring. Next legislative session begins January 2015. Also July 20-23 a team will attend the SACSCOC Summer conference. We continue to work on our SACSCOC Accreditation report (due Spring 2015).

House Bill 5 – Update

July 17, 2014

Three committees were created to address House Bill 5 requirements for college readiness at the secondary level. The purpose was to locally develop courses to provide an opportunity for students to demonstrate college readiness in math and/or ELA (English Language Arts) so they are able to begin as freshman without remedial or developmental courses. The committees consisted of:

- ELA (English/Language Arts) committee- developed reading/writing course curriculum
- Math committee- developed math course curriculum
- Operational committee- developed the Partnership Agreement between area high schools and SWTJC regarding the courses, who will teach them, what grades and assessment will determine successful completion, etc.

All committees had representation from large, medium and small districts. Representation included Eagle Pass, Del Rio, Uvalde, Medina Valley, Knippa, Brackettville, Carrizo Springs, Dilley and Natalia. One or more of the committees met on our campus on March 18th, March 21st (Region 20 representative), April 10th, April 22nd, May 13th, May 20th, June 11th. On June 19th SWTJC hosted a House Bill 5 informational meeting for all districts. The DRAFT Partnership Agreement was presented along with open discussions about the overall process of course implementation and the responsibilities that both secondary and SWTJC will have.

On August 11th and 12th SWTJC will provide professional development for high school instructors teaching the college readiness courses.
